

# TRIP TERMS AND CONDITIONS

Your **CREDIT CARD STATEMENT** will show your travel purchase as “**Aquatic Dreams Scuba Center**”. “*Tour*” refers to the travel arrangements listed on your invoice. “*Client*” refers to the passengers on the tour. “*Suppliers*” refers to any airline, hotel, dive shop, live-aboard, transportation company or other vendor supplying any or all of the client’s tour.

## RESERVATIONS AND PAYMENT

When signing up for a trip, Aquatic Dreams Scuba Center will hold your spot on the specified trip after an initial **\$500 NON-REFUNDABLE, NON-TRANSFERABLE DEPOSIT** has been received. Additional deposits may be required. Final payments are due 120 days prior to departure. For international destinations, Aquatic Dreams Scuba Center will setup a monthly payment plan. For trips that are more than \$5,000, half of trip payment is due 16 months prior to departure.

\_\_\_\_\_ All prices are based upon double occupancy. I understand that if I sign up as a single person, Aquatic Dreams Scuba Center will do their best to match me up with a roommate. If Aquatic Dreams Scuba Center is unable to provide a roommate, I agree to pay the single occupancy cost.

I understand that final prices are subject to change due to unforeseen cost at the time of booking or any additional taxes or surcharges imposed by the airlines, vendors or government. On tours that are posted with an **estimated price**, the client is hereby advised that the price has not been finalized and the trip price will be set when all final numbers have been received. Aquatic Dreams Scuba Center will do all it can to keep the price as close as possible to the estimated price. The client is accepting to place down a **NON-REFUNDABLE, NON-TRANSFERABLE DEPOSIT** for this tour freely knowing that the price may have an increase because of unforeseen fuel surcharges and airline fees.

## CANCELLATION POLICY

In the event that you need to cancel a trip, you will incur a cancellation fee of the **NON-REFUNDABLE, NON-TRANSFERABLE DEPOSIT** per person and any other expenses that have occurred. Cancellations must be made in writing. Cancellations made prior to 120 days before the trip will have everything but the deposit refunded back to you. Cancellations made after 120 prior to departure will be charged 100% of trip fees. **Travel insurance is highly recommended (see below)!!!**

The travel agencies that Aquatic Dreams Scuba Center contracts with has special contract airfares with air carriers. These special fares have several restrictions. Once airline tickets have been issued, these tickets are **NON-REFUNDABLE, NON-TRANSFERABLE, NON-REROUTEABLE and NON-CHANGEABLE** without total loss or penalty. Aquatic Dreams Scuba Center acts only as agent for the carrier, hotel, tour operator, vessel, boat or other facility providing the travel accommodations, activities, tours, excursions and other travel services. Aquatic Dreams has no control or ability to control the same.

## TRAVEL INSURANCE

Travel insurance is **HIGHLY RECOMMENDED!!!** Go to the travel page on aquaticdreams.com and click on the link “*DAN Trip Insurance by AIG*” for a quote on your trip.

## DIVE INSURANCE

DAN Diver Protection is **REQUIRED**. Go to [aquaticdreams.com](http://aquaticdreams.com) and click on the link "*DAN Join Today*". If you do not wish to join Divers Alert Network and purchase their Diver Accident Insurance, proof of another plan you have that covers you for an out-of-the-country accident including medical flight evacuation cost is acceptable.

## PASSPORTS AND VISAS

All countries require that your passport be valid for **SIX MONTHS** after date of return. Your passport must have enough **BLANK PAGES** for the required visa stamps.

## RESPONSIBILITY

Aquatic Dreams Scuba Center shall be responsible to the client for supplying the services and accommodations offered on the client's invoice except to the extent such services and accommodations cannot be supplied due to causes beyond the control of The Agency. The client waives any claim against The Agency for any damages to or loss of property, or any injury to or death of any client during the clients tour. The Agency shall not be responsible for any floods, fires, tropical storms or other acts of nature, nor for delays, substitution or equipment or any act or omission by any supplier, its agents or employees. *As such, I recognize that Aquatic Dreams Scuba Center is NOT responsible for injuries, losses or damages to me, my luggage or dive equipment and I waive any such claims against Aquatic Dreams Scuba Center for such injuries, losses and damages, certain environmental, travel or weather conditions beyond the control of Aquatic Dreams Scuba Center may affect the travel arrangements and/or dive operation and are not the responsibility of Aquatic Dreams Scuba Center.* The client hereby waives any claim arising there from. The right of the client is reserved to claims against suppliers. The Agency reserves the right to decline a client as a participant in a tour at any time. In the event a tour is cancelled by The Agency, The Agency shall have no responsibility beyond the refund of all deposits made to The Agency by the client. Any direct contact between the client and a supplier shall constitute the sole contract between the supplier and the client.
